By His Excellency George Grey Esquire Governor and Commander-in-Chief of Her Majesty's Province of South Australia and its Dependencies and Vice-Admiral of the same by and with the advice and consent of the Legislative Council.

AN ORDINANCE to Authorize the Levying of Fees on the Slaughtering of Cattle in South Australia.

WHEREAS by an Act or Ordinance of the Governor with the Preamble.
advice and consent of the Legislative Council of South Australia passed on the eighth day of December one thousand eight hundred and forty intituled "An Act to regulate the Slaughtering and prevent the Stealing of Cattle" it is enacted "that it shall be 4 Vic., No. 5.
lawful for His Excellency the Governor from time to time to appoint Sec. 6.
within such towns or districts or parts of districts as to him shall seem fit by a notice to be published in the *Government Gazette* Inspectors of Slaughter-houses and of Brands and of the skins of Slaughtered Cattle:" And whereas it is necessary to provide for the remuneration of such persons acting in execution of the said Ordinance in manner hereinafter mentioned:

Be it therefore Enacted by His Excellency the Governor of South Australia with the advice and consent of the Legislative Council thereof

Inspectors of Slaughter-houses authorized to levy dues.

thereof: That from and after the passing hereof it shall be lawful for every Inspector aforesaid to levy collect and receive from every party who shall bring any head of Cattle or Stock to be slaughtered to any Public Slaughter-house appointed under the provisions of the said recited Ordinance the respective dues specified and contained in the Schedule hereto annexed: Provided always that it shall be lawful for the Governor from time to time as occasion may require by Proclamation of His Excellency published in the *Government Gazette* to vary and reduce and again to advance the said dues not exceeding the maximum dues specified in the said Schedule and the said several Inspectors shall at least once in every week make a return of all such dues received by them respectively verified under their respective hands and shall forthwith pay the amount thereof to the Colonial Treasurer on behalf of Her Majesty Her Heirs and Successors for the public use of the Province and support of the Government thereof.
