An Act to amend the Waterworks Act, 1932-1974; the Sewerage Act, 1929-1975; the Land Tax Act, 1936-1974; the Local Government Act, 1934-1975; and the Irrigation Act, 1930-1974.

[Assented to 20th November, 1975]

BE IT ENACTED by the Governor of the State of South Australia, with the advice and consent of the Parliament thereof, as follows:
