An Act to authorise the construction of an Additional Reservoir and other Works for the purpose of facilitating the Supply of Water to the District of Glenelg.

[Assented to, October 25th, 1880.]

WHEREAS it is desirable to authorise the construction of an Preamble. additional reservoir and other works for the purpose of facilitating the supply of water to the District of Glenelg, according as such district is defined in the Schedule to "The Glenelg Waterworks Act, 1878": and whereas plans and sections showing the source of supply and the said reservoir, and other works, and the direction of the main and branch pipes, and the streets and grounds through which they are to be laid, have been deposited in the office of the Surveyor-General, at Adelaide—Be it therefore Enacted by the Governor of the Province of South Australia, with the advice and consent of the Legislative Council and House of Assembly of the said province, in this present Parliament assembled, as follows:

1. The Commissioner of Waterworks may take possession of that piece of land, being portion of the Adelaide Park Lands, which is described in the Schedule hereto, and thereon may construct, out of any moneys which have been or may hereafter be voted by Parliament for the purpose, the additional reservoir and other works according to the said plans and sections deposited as aforesaid in the office of the Surveyor-General, at Adelaide: Provided however, that the said Commissioner shall, upon the completion of the said reservoir and other works, cause the piece of land hereby authorised

to be taken, to be enclosed by a proper fence and planted, and the said Commissioner shall cause the said reservoir to be and remain covered as shown in the said plans and sections, and shall at all times after the completion of the said reservoir and other works, and the said fence and plantation, permit the public to have access by footways to the said piece of land, and the said Commissioner shall at all times after the completion thereof cause such fence, plantation, and footways to be kept in proper repair: And provided also, that if from any cause the occupation by the said Commissioner of the said piece of land, for the purposes of this Act, shall at any time hereafter cease, the care, control, and management of the said piece of land shall revert to the Council of the City of Adelaide.

Interpretation.

2. In the construction and for the purposes of "The Adelaide City, Port, and Suburban Waterworks Act," and of this Act, except when such meaning would be inconsistent with the context, the word "Undertaking" shall include in addition to the meaning assigned thereto by the said "The Adelaide City, Port, and Suburban Waterworks Act," the reservoir and other works hereby authorised to be constructed.

Short title.

3. This Act may be for all purposes cited as the "Glenelg Waterworks Act, 1880."

Incorporation.

4. Except so far as the same is inconsistent with or altered by this Act, this Act and "The Adelaide City, Port, and Suburban Waterworks Act," shall be incorporated and read as one Act.

THE SCHEDULE REFERRED TO.

Comprising all that portion of the South Park Lands, City of Adelaide, within a radius of 125 feet, from a point 400 feet south of the southern boundaries of Town Acres 662 and 663, and 250 feet west of a line being the production southerly of the eastern boundaries of Town Acres 661 and 662.
